The successful applicant must possess the following qualifications:

- Enrolled as a first year or second year student at a two-year College Powerline Technician program.
- Ability to demonstrate a 3.0 cumulative grade point average.
- Must be able to carry out the physical work demands of the position including heavy lifting, stretching, pulling, etc.
- Must be able to work in extreme weather conditions.
- Must be able to work in confined spaces.
- Must possess excellent oral and written communication skills in order to work with staff and customers in a tactful and diplomatic manner.
- Must possess and demonstrate mechanical aptitude and produce accurate inspection records either electronically or through the completion of a printed form.
- Must show initiative and demonstrate the ability to make sound decisions, flexibility of approach, ability to assume responsibility and the capability to perform both independently and in a team environment.
- Shall have demonstrated a history of safe work practices.
- Must possess a current CPR and First Aid Training Certificate or the ability to complete certification prior to commencement of work with ENWIN Utilities Ltd.
- Minimum requirement of a valid Class "G" Ontario Driver's Licence. A Valid Class "A" Ontario Driver's Licence with "Z" endorsement would be considered an asset.
- A current Working at Height Training Certificate is considered an asset.
- Successful completion of supplementary training courses with IHSA related to the Powerline Technician program is considered an asset.
