- Must possess and demonstrate mechanical aptitude and produce accurate inspection records either electronically or through the completion of a printed form.
- Must show initiative and demonstrate the ability to make sound decisions, flexibility of approach, ability to assume responsibility and the capability to perform in a team environment.
- Shall have demonstrated a history of safe work practices and be familiar with the Utility Work Protection Code.
